#### Dear Michael:

With this letter I want to express my gratitude and congratulations to you and your staff of consultants from Guidance in Giving, Inc. for the exemplary service and leadership you provided in our recent diocesan campaign, One in Faith and Mission.

When I formed the task force to explore the feasibility of embarking on a first time ever capital campaian in the Diocese of Lexinaton, the task force received nine proposals from nationally based consulting firms. Four were invited to make in person presentations and Guidance in Giving was unanimously recommended to do the feasibility study. 



I have been asked to give my impression of your recent financial campaign to assist our diocese of Lexington, Kentucky.

We are a diocese of only 23 years and also a divided area as far as cultural heritage is concerned.

Please allow this letter to serve as a request to consider your firm as development/fund-raising consultants for a potential capital campaign at The Church of Saint Agnes, 1680 Dixie Highway, Fort Wright, KY 41011-2779.

It is our desire to improve the structural and environmental surroundings of our school and make it consistent with our designation by the U.S. Department of Education as a Blue Ribbon School for academic superiority. Smaller scale repairs and/or capital improvements are also being considered to the parish physical plant.

Saint Agnes Parish has 1,600 families with 1,200 of those being considered active. Our parish school, Saint Agnes Catholic School, serves approximately 410 students in Kindergarten through eighth grade. The initial feasibility study estimates the project scope to be \$4.5-5 million.

In conjunction with our committee your mission will be to determine if we have the resources available for the project and to assist us in securing appropriate funding for this worthwhile endeavor. As we enter this proposal stage we will be most interested to have you:

- Define your methods of handling a feasibility study, case statement, marketing, solicitation and campaign management.
- Provide an approximate time line.
- State your fees for services, including your expectation for expenses to be reimbursed.
- Request physical needs on site (office space, computer, etc.).
- Provide three references of previous clients that you assisted with similar scope and size of project. Prior experience with capital campaigns involving a parish school should be included.
- Provide information about your firm's work in Northern Kentucky (history, number of clients, etc.).

Thank you for your consideration. Responses must be postmarked by March 12, 2010 to be considered for this work.
