The business office at the parish is very lean when it comes to the workload to run our parish. We were concerned that the addition of a major campaign would "break the back" of our small group. The personal consultant assigned to our parish "Director Renee Polka" came in and rather than assigning many new tasks, created and executed almost all of the actions required to launch, execute and support the campaign. She was a breath of fresh air to the pastor and the entire staff.

The Executive Vice President Steve Babcock created a pleasant environment & attitude during the campaign negotiations and assisted greatly in our project presentation to the Archdiocese Review Board.

The Director Renee Polka was fantastic throughout the campaign. She rolled up her sleeves and jumped right into parish life. Joining the staff in daily prayer and taking part in our day to day struggles. Renee is a very talented campaign director and a fantastic person. She provided vendors, printed materials and processed all mailings with no other support other than Father's approval.

The financial controls used by Guidance and Giving were incredible. It allowed complete control of the campaign while we managed to get the parishes systems set up and capable of taking over the campaign by sending monthly reminders and tracking pledges. The final hand off was seamless and the remainder of the follow up was minimal.

The results of the campaign have exceeded our parish expectations. Over \$5,500,000 pledged thus far – 69% of the project cost (8.5 x annual offertory) with potential and a plan to surpass the \$6,000,000 needed to secure the loan for the new church construction. It is surprising to have this much success only six months into our campaign. Wow!
